1. Approval of the 08 December 2020 Meeting Minutes and the Agenda for 09 March 2021 was approved and carried by unanimous vote.

## 2. Topics

A. Reliever Airport Updates

Mike Wilson, Philip Tiedeman, and Blaine Peterson, MAC gave an update on the 2021 projects at each airport:

- STP Taxi-lane edge lighting project east of runway 14/32 will commence in June 2021.
  - Tower regular hours starting March 28, 2021.
  - Airport Security Police will be on-site starting March 15, 2021.
  - International Flights continue to see more operations.
- 21D Runway 14-32 Replacement project timeline 2020-2022 (4 phases).
  Hangar Development four hangars near completion and others in various stages of development.
  - MnDOT Aeronautics is working on repairing the anemometer.
- ANE Hangar Development new hangar construction on the south end commencing in Spring 2021.

- Taxi-lane pavement reconstruction will commence in Spring/early Summer 2021.
- Aesthetics and Hangar Use Issues Staff is working with multiple tenants on hangar improvements.
- Tower Equipment MnDOT Aeronautics will be performing the maintenance.
- MIC Hangar Development two hangars under construction on the north side with additional hangar construction to begin.
  - Tower regular hours starting March 28, 2021.
  - Sign Project upgrading certain signs to LED.
  - Turf Runway will open as soon as it is safe.
  - E1 Runup Pad Tower has developed new procedures.
  - Restaurant Holman's Table re-opened March 3, 2021.
- LVN Wash Rack Area the electronic valve issue has been repaired.
  - South Hangar Development Area has been progressing gas and power work will commence in Spring 2021.
- FCM Hangar construction has been progressing new and ongoing.
  - South Hangar Development Area gas and power work will commence in mid-April 2021.

**Rob Dockry, MAC** reported that the Crystal Airport fuel sales for 100LL and Jet A remain to exceed MAC's expectations.

## B. Quarterly Reliever Review

**Kelly Gerads, MAC** reported that the Reliever Airports have been doing very well given the pandemic.

Activity Based Revenue 2019 vs. 2020:

- Percentage Rent Revenues show a 1% decrease year-to-year
- Landing Fees show a 29% decrease year-to-year
- Fuel Flowage Fees show a 21% decrease year-to-year
- Jet A Total Gallons show a 31% decrease year-to-year
- 100 LL Total Gallons show a 2% increase year-to-year
