






AVERAGE PASSENGERS PER FLIGHT




2023 MSP CARRIER JET USAGE WITH CUMULATIVE CERTIFICATED NOISE LEVELS


AVERAGE ALTITUDE FOR AIRCRAFT ARRIVING TO MSP






MEASUREMENT GATE IS FIVE NAUTICAL MILES FROM THE THRESHOLD OF THE ARRIVAL RUNWAY


AVERAGE ALTITUDE FOR AIRCRAFT DEPARTING FROM MSP

AVERAGE DAILY NIGHTTIME OPERATIONS



















SCHEDULED VERSUS ACTUAL OPERATIONS




DAILY SCHEDULED NIGHT OPERATIONS
