APPROVED MEETING MINUTES

Lydia Werner, Metropolitan Airports Commission, convened the Crystal Airport Joint Airport Zoning Board meeting at 8:00 AM. The following were in attendance:

1. WELCOME AND AGENDA OVERVIEW

Lydia Werner opened the meeting and welcomed the attendees to the first convening of the Joint Airport Zoning Board for Crystal Airport. Ms. Werner stated that she would lead the meeting but that the Board would be selecting its chairperson.

2. BOARD MEMBER INTRODUCTIONS

Ms. Werner explained that the Board is made up of members from Brooklyn Center, Brooklyn Park, City of Crystal, City of New Hope, Minneapolis, and Robbinsdale. Bridget Reif, Metropolitan Airports Commission, added that Rod Skoog, present, is one of two MAC commissioners also on the board. Each municipal government is entitled to have two primary members on the Board, along with two alternate members who can vote in the absence of a primary member. Ms. Werner introduced the board members and which municipal government they represented.

3. JAZB PURPOSE & ROLE

Ms. Werner highlighted the JAZB's purpose to collaboratively develop an airport zoning ordinance that achieves a balance between providing for a reasonable level of safety while allowing for compatible community development.

4. <u>SELECTION OF CHAIRPERSON</u>

Ms. Werner read aloud Minnesota Statute section 360.063, describing JAZB requirements. Ms. Werner explained that the Chair must be someone in addition to the Board members, and not one of the members or alternates appointed by the municipalities or the MAC. If a member of the JAZB fills the role of chair, their municipalities seat must be backfilled. Ms. Werner asked for nominations.

Hearing none, Ms. Werner cited Rick Weyrauch, the chair of for Lake Elmo's Joint Airport Zoning Board, as an experienced candidate that expressed an interest in the role if Crystal's JAZB chooses to nominate him. The board discussed and favored this option.

GEORGE SELMAN, ROBBINSDALE, MOVED TO APPOINT RICK WEYRAUCH AS CHAIR OF THE CRYSTAL JOINT AIRPORT ZONING BOARD. JEFF SARGENT, NEW HOPE, SECONDED. THE MOTION CARRIED BY UNANIMOUS VOTE.

5. ORGANIZATIONAL LOGISTICS

Ms. Werner presented recommendations for organizational logistics for the JAZB meetings. Ms. Werner suggested using Robert's Rules of Order to guide meeting protocols. Ms. Werner defined a quorum as having a majority of JAZB membership in attendance to take action, meaning that eight members, including alternates, must be present to take any formal actions, and that formal actions will require a majority vote of members present to pass or fail. Ms. Werner called for a motion to adopt Robert's Rules of Order.

IT WAS MOVED BY RICK PEARSON, ROBBINSDALE, SECONDED BY GEORGE SELMAN, TO ADOPT ROBERT'S RULES OF ORDER. THE MOTION CARRIED BY UNANIMOUS VOTE.

Ms. Werner and Evan Wilson, Metropolitan Airports Commission, presented meeting format options for the board to choose their format going forward, whether entirely in person, entirely remote, or a hybrid of the two. Mr. Wilson explained the legal restriction on voting for board members attending remotely. After a brief discussion, a hybrid of inperson and remote video and conference calling was determined to be the best option. Mr. Wilson promised to look into and follow up with the board regarding the legal restriction of voting when attending remotely. Ms. Werner promised to inquire with those stakeholders not in attendance, and to follow up with the board regarding next meeting and format details. Mr. Sargent promised to check on the availability of a technologically capable meeting room in the City of New Hope's City Hall, to accommodate hybrid meetings.

6. GOALS FOR THE CRYSTAL AIRPORT JAZB

Ms. Werner stated that the overarching goal for this Board is to develop an airport zoning ordinance for review and approval by the MnDOT Commissioner of Transportation for subsequent adoption by the Board and then local communities. To accomplish this, the JAZB could consider a few sub goals. First, the Board should keep in mind that this is a balancing act between providing a reasonable level of safety while allowing for compatible community development. The Board should ensure that the ordinance is developed in a manner that includes meaningful stakeholder engagement.

7. ELEMENTS OF AN AIRPORT ZONING ORDINANCE

Evan Barrett, of Mead & Hunt, presented land use and structure height restrictions as the primary elements of an airport zoning ordinance. He explained Federal Aviation Regulations (FAR) Part 77 airspace surfaces. He presented Crystal's existing ordinance adopted in 1983, and the airspace restrictions therein.

8. <u>AIRPORT ZOING PROCEDURAL STEPS</u>

Mr. Barrett outlined the anticipated meetings and procedural steps involved in an airport ordinance and introduced the difference between standard and custom modeling. Mr. Barrett proposed that the next meeting focus on a work session getting into the details of the two airport zoning pathways, Custom or Commissioner's Standard. The desired outcome from the second meeting would be a decision about which airport zoning method the JAZB desires to pursue. The content of the third meeting would be based on the JAZB's decision. If the JAZB selects the Custom method, the third meeting would focus on a review of the custom zoning factors and developing a methodology for constructing the ordinance. The result for the initial phase of the JAZB's work is a public hearing to present the proposed airport zoning ordinance for public review and comment, followed by its submittal to MnDOT for review and approval.

9. INITIAL MEETING PLAN

Ms. Werner outlined November 16th at 10 am for the next JAZB meeting, to get it in before the holidays, and early 2022, January or February, for the 3rd meeting.

10. PUBLIC COMMENTS

No public comments were received.

12. <u>ADJOURN</u>

The meeting was adjourned at 9:45 AM.

1. WELCOME AND AGENDA REVIEW

Ms. Lydia Werner opened the meeting by introducing the agenda and Rick Weyrauch as JAZB Chair.

2. INTRODUCTION OF CHAIR

Mr. Rick Weyrauch introduced himself as a supervisor at Baytown Township, previous chair of the Lake Elmo JAZB, and former pilot. He described his role as facilitator of the Crystal JAZB.

3. MEETING FORMAT & LOGISTICS

Ms. Werner presented the Open Meeting Law requirements that apply to meeting in a hybrid format with some JAZB members physically present and some attending remotely. JAZB members discussed the hybrid option, an all-virtual option, and the in-person option.

4. APPROVAL OF MINUTES FROM OCTOBER 12, 2021 MEETING

GEORGE SELMAN MOVED TO APPROVE MINUTES FROM THE OCTOBER 12TH MEETING AND JOSEPH SEARS, CRYSTAL, SECONDED.

THE MOTION PASSED UNANIMOUSLY.

5. JAZB PURPOSE & ROLE

Ms. Werner reviewed the purpose and goal of the JAZB.

6. STATE AIRPORT ZONING STATUTE – MNDOT OFFICE OF AERONAUTICS

Mr. John Fleming introduced himself as a regional planner at MnDOT with a focus in zoning. He presented a rough overview of the statutory requirements for airport zoning.

7. BASIC AIRFIELD SURFACES

Mr. Evan Barrett introduced himself as an Airport Planning consultant for Mead & Hunt, providing technical support to the MAC for the zoning process. He then provided an overview of Basic Airfield Surfaces.

8. <u>1983 AIRPORT ZONING ORDINANCE</u>

Mr. Barrett continued by re-capping the 1983 Zoning Ordinance.

9. MNDOT COMMISSIONER STANDARD ORDINANCE

Mr. Barrett continued by comparing the 1983 ordinance to the current Commissioner's Standard Ordinance.

10. AFFECTED LAND USES & PARCEL

Mr. Barrett concluded by detailing Affected Land Uses & Parcels.

11. CUSTOM ORDINANCE CASE STUDIES

Mr. Brad Juffer introduced himself as a member of the Community Relations office for the MAC. He reviewed the technical analysis of the Flying Cloud Airport in 2017, 2018, and 2019, and then at the Lake Elmo Airport for JAZB processes in 2019 and 2020. He then reviewed with the board some custom ordinance case studies.

12. DISCUSSION OF AIRPORT ZONING LIABILITY

Mr. Wilson introduced himself as Legal Counsel for MAC, presented information regarding liability and risk associated with airport zoning, and encouraged JAZB members to discuss these issues with their municipality's legal counsel.

13. DETERMINE ZONING PROCEDURE (COMMISSIONER STANDARD VS. CUSTOM)

Chair Weyrauch asked for further discussion toward determining this JAZB's zoning procedure, and a lengthy discussion continued.

Mr. Barrett brought up that there might be some discussion with MnDOT whether they accept the JAZB definition of Existing Land use because it's not spelled out in the statute.

Mr. Junior Lindsay, MnDOT, offered to provide that definition within a couple weeks.

Ms. Bridget Rief, Metropolitan Airports Commission, asked that MnDOT also include, on these exempted properties, what happens if there's damage or a fire - is re-construction allowed?

Mr. Lindsay explained that what's grandfathered is the type of use, not the explicit building.

Chair Weyrauch summarized that the consensus of a few people seemed to be that was no way to really make the decision on which zoning process to follow. He asked if anyone was ready to call a motion and the JAZB deferred the decision. Chair Weyrauch advised board members to use the time before the next meeting to review the material and consult with people back at each municipality. He asked for questions or comments to be submitted between now and when we meet again to try and get these answers prepared.

14. MEETING PLAN

Ms. Werner oriented the board to the meetings held thus far and the plan for meetings yet to come. She stated the next meeting will be in January, that MAC will send that invite out as soon as calendars are coordinated, and that MAC will work with Brooklyn Park to confirm we can use the space and make sure it's set up for hybrid meeting requirements.

15. PUBLIC COMMENTS

Chair Weyrauch asked that we always have a public comment period in the agenda, and that it goes ahead of any decision points. He asked whether any member of the public would like to make a comment. [No public comment was received.]

16. ADJOURN

Chair Weyrauch stated he would accept a motion to adjourn.

Olson expanded that the proposed light rail and re-development area would benefit from a table of these restrictions.

Paul Mogush, with Brooklyn Park, said this would benefit Brooklyn Park as well, and asked if Crystal and Brooklyn Park could send in their areas of concern.

Barrett agreed that he could look at it before the next meeting, though the basic gridwork is likely to resolve property questions.

Weyrauch explained that the draft zoning ordinance at the next meeting will be much more detailed and is likely to address property questions.

To questions of terms and definitions varying between city regulations and the airport zoning ordinance, Wilson recommended board members discuss with legal counsel of municipalities.

Board members also discussed various matters related to land use restrictions in Safety Zone 1.

8. AIRPORT ZONING PROCEDURAL STEPS

The board discussed giving members additional time to review technical details of the draft ordinance.

- 4. Board Discussion of Draft Airport Zoning Ordinance Materials

Eric Gilles, Airport Planner for the Metropolitan Airports Commission, reviewed questions and answers discussed with individual board members since meeting #5. Board members asked questions to clarify permitting responsibilities and turn-around time.

Gilles addressed questions regarding 7460 reviews. A supplemental of the permitting application process can be found in both the meeting attachments and on Crystal's JAZB website.

In response to board discussion on the length of an FAA review, Gilles agreed the FAA approval process can take months and offered to help shepherd the process when needed.

Gilles clarified that objects below the height restrictions shown in the grid maps of the ordinance may pass without further review. If FAA approval is needed, there may be a request to complete a survey of validation, whether the object is marked, lighted, hazardous, etc.

In response to board discussion of tree trimming, Wilson clarified that enforcement of the ordinance is the responsibility of the City Zoning Administrator, but MAC will assess & assist.

Gilles asked that any question that comes up be an in-tandem discussion between the municipality and himself.

In reference to updates made to the draft ordinance regarding parks, Gilles pointed out that "non-spectator" had been removed and "dense confined" had been added to modify "assembly of persons." He confirmed only entirely new structures or expansions would be subject to the ordinance.

Board members were assured municipalities would retain the ability to maintain and repair existing non-conforming structures. Though an airport zoning permit is required, the process can be as simple as the city wants it to be, such as a simple review ensuring nothing was added that wasn't pre-existing. And if it were to happen that the building is destroyed, a permit can be granted to rebuild it according to the original footprint.

5. Risk Assessment – Adjacent Public Parks in Zone 1

With reference to slides 7 & 8, the board discussed the inclusion of parks adjacent to airport property in Safety Zone 1.

6. Board Discussion of Advancing to Public Hearing

Chair Weyrauch asked whether members needed more time to discuss with their municipalities or if they were ready to move forward.

Dan Olson, City of Crystal, requested additional time to get input from his city on the new materials and answers provided.

Board members determined they would convene next on December 14.

7. <u>Airport Zoning Ordinance Development Review Guideline</u> (FCM Example)

Board members agreed to review.
