## **METROPOLITAN AIRPORTS COMMISSION**

## ORDINANCE NO. 38

AN ORDINANCE REGULATING THE PRESENCE OF JUVENILES ON AIRPORT PROPERTY AND DEFINING THE DUTIES OF RESPONSIBLE ADULTS.

The Minneapolis-Saint Paul Metropolitan Airports Commission does ordain:

**SEC. 1 – Definitions:** As used in this ordinance, the following terms shall mean:

- 1.1 <u>AIRPORT</u> Minneapolis-Saint Paul International Airport-Wold Chamberlain Field, a public airport, under the supervision, operation, direction and control of Minneapolis-Saint Paul Metropolitan Airports Commission and located in the County of Hennepin, State of Minnesota.
- 1.3 <u>JUVENILE</u> An individual under eighteen years of age.
- 1.4 <u>RESPONSIBLE ADULT</u> The parent, guardian, or adult specifically authorized by law or by a parent or guardian to have custody and control of a juvenile.

**<u>SEC. 2 – Curfew:</u>** It shall be unlawful for any juvenile to be on or present in any airport property or facility or any airport property or facility leased to a third party between the hours of 10:00 P.M. and 5:00 A.M. the following day unless:

- a) the juvenile is accompanied by a responsible adult; or
- b) the juvenile is at the airport as a result of his arrival on passenger aircraft; or
- c) the juvenile is at the airport in anticipation of his departure via passenger aircraft.

**<u>SEC. 3 – LOITERING</u>**: It shall be unlawful for any juvenile to loiter, loaf, or idle on or near any airport property or facility unless accompanied by a responsible adult.

**SEC. 4 - ADULT RESPONSIBILITY:** It shall be unlawful for any responsible adult to knowingly or negligently permit a juvenile for whom he is responsible to violate any of the provisions of this ordinance.

**SEC. 5 - BUSINESS ESTABLISHMENT RESPONSIBILITY:** It shall be unlawful for any proprietor or manager of any business establishment located on airport property to permit a juvenile to remain in his place of business during such hours and under conditions which are prohibited by this ordinance.

**SEC. 6 – PENALTY:** Any person violating any of the provisions of this ordinance shall be guilty of a misdemeanor and upon conviction shall be punished by a fine not exceeding \$300.00 or by imprisonment for a period not exceeding ninety days, or both.

**SEC. 7 – SEVERABILITY:** Each separate provision of this ordinance shall be deemed independent of all other provisions herein, and if any provision of this ordinance shall be declared invalid all other provisions thereof shall remain in full force and effect.

<u>SEC. 8 - EFFECTIVE DATE</u>: This ordinance upon its adoption and upon filing the same with proof of publication with the Secretary of State of the State of Minnesota shall thereafter be in full force and effect.
